At least the first quarter (*i.e.* first three months) of the preliminary estimated monthly amount of electricity consumed under this of the contract shall be paid by bank transfer to the following account number. **0000000000**, GUARANTY TRUST BANK. During this first quarter of connection, the Electric Power Supplier, hereinafter referred to as XENERGI LIMITED, shall prepare the permanent monthly electric power bill from the average amount of electricity consumed by the client during this **first three (3) months** of connection. As provided in SCHEDULE 1 of this Connection Agreement, XENERGI LIMITED issue a Yearly Electric Power Bill based on this three-month average amount of electricity consumed by the customer. The customer may choose to make a regular monthly or yearly payment based on this Yearly Electric Power Bill issued by XENERGI LIMITED.

VALIDITY, EFFECTIVENESS AND DURATION OF THE CONTRACT

- 1) The contract enters into force on the day of its issuance and takes effect on the day of connection, but not before the day of validity of the contract.
- 2) The Contract is concluded for:

 DEFINITED PERIOD OF TIME TO:
- 3) The contract may be terminated:
 - a) as agreed by the Contracting Parties,
 - b) upon termination of this Connection Agreement or the Agreement on Combined Electricity Supply Services (within the framework of the Framework Distribution Service),
 - c) withdrawal by XENERGI LIMITED; Withdrawal is effective on the day of delivery of XENERGI LIMITED's written notice of withdrawal to the customer's delivery address, or later notified on the day after delivery of XENERGI LIMITED's written notice of withdrawal.
- 4) XENERGI LIMITED has the right to withdraw from the Contract if the Customer is in arrears with the fulfillment of the obligations under the paragraph **PAYMENT RATE** for a period longer than 5 working days. In the event that this happens, XENERGI LIMITED declares that it is withdrawing from the Contract, with the effects of withdrawal taking effect in vain upon expiry of the said reasonable replacement period.
- 5) The Contract shall terminate if it is not concluded within 36 months from the effective date of its signature the supplier, hereinafter referred to as XENERGI LIMITED, is not capable of supplying the required amount electricity to the Customer's connecting or offtake point, unless there is sufficient reason for this on the part of XENERGI LIMITED or after the expiration of 60 months from the date when the Electricity Distribution Agreement concluded with the Customer for the offtake equipment at the Customer's offtake point expires.

COMMON AND FINAL PROVISIONS

- 1) The Customer declares that he has the consent of the owner of the real estate in which the offtake point is located to conclude this Agreement.
- 2) The contract may be amended by agreement of the parties in a manner other than in writing.
- 3) On the effective date of the Agreement, any previous agreements on the connection of the offtake point, which is the subject of this Agreement, shall terminate.
