



Brickell Key

The man-made island of Brickell Key is a 44-acre, master-planned community located at the mouth of the Miami River in downtown Miami. Brickell Key's master developer, Swire Properties, which invested \$1 billion into the property starting with its first development, Brickell Key One, controls all undeveloped land on the island. The island is dotted with artistic sculptures and lush landscaping including 20,000 transplanted trees.

To date, a sampling of buildings completed within Brickell Key:

Mandarin Oriental Miami

Completed in 2000, Mandarin Oriental is a 20-story luxury hotel overlooking Biscayne Bay with 328 rooms and suites.

Courts Brickell Key

Completed in 2003, Courts Brickell Key is a 34-story condominium with 319 units.

One, Two, Three Tequesta Point

- $\cdot\,$ One- Completed in 1995, 30-story condominium with 289 units.
- Two-Completed in 1999, is a 40-story condominium with 268 units
- Three- Completed in 2001, is the tallest of three high-rises by the same name. The tower is a 48-story, waterfront condominium with 236 units.

Completed in 2005, Carbonell is a 40-story, waterfront condominium with 284 units.

Asia

Completed in 2008, Asia is an ultra-luxury, waterfront condominium with 123 units.


Brickell City Centre

Brickell City Centre

A \$1.05 billion mixed-use complex built on nine acres along South Miami Ave between Sixth and Eight Streets in the heart of Miami's bustling financial district. Brickell City Centre offers 4.9 million square feet of retail, office, luxury residential, hotel and entertainment space, plus an unprecedented two-level underground parking garage.

Coined Miami's "city within a city", Brickell City Centre unveiled its first phase in November 2016, comprising of two luxury residential towers – REACH and RISE, two mid-rise office buildings – TWO BCC and THREE BCC, and EAST, Miami Hotel, all towering above the ultimate amenity – a 500,000 square foot open-air retail center. The Centre boast 120 storefronts and four levels of unparalleled shopping, dining and entertainment anchored by an ultra-modern Saks Fifth Avenue, luxury dine-in theater CMX VIP Cinema and Italian food hall Luna Park. The project's three city blocks are all connected by its architectural crown jewel, the CLIMATE RIBBON™; the larger-than-life canopy of steel and glass that spans 150,000 square feet, acting as a sophisticated environmental management system protecting shoppers from South Florida's heat and rain.

In 2018, Brickell City Centre earned LEED® Gold certification for Neighborhood Development, along with six additional LEED certifications placing the project in a class of its own for sustainable development.



Four levels of world-class shopping, dining and entertainment are interconnected over three city blocks, featuring over 120 premium shops and eateries. Brickell City Centre is the home of designer style, anchored by Saks Fifth Avenue and featuring leading brands, including Chanel, Lululemon, Intermix, Hugo Boss, Iro, Maje, Illesteva, Acqua di Parma and Zara among others. Exquisite dining ranges from cozy cafés and gelato shops to the neighborhood's trendiest restaurants, while a luxury cinema experience can be enjoyed at CMX VIP Cinema.

Arquitectonica Bernardo Fort-Brescia, FAIA

Arquitectonica is an architecture, interior design and planning firm that began in Miami in 1977 as an experimental studio. Led by Bernardo Fort-Brescia and Laurinda Spear, the studio has evolved into a worldwide practice, combining the creative spirit of the principals with the efficiency of delivery and reliability of a major architectural firm.

Bernardo Fort-Brescia is a founding principal of Arquitectonica. A native of Lima, he did his early studies in Peru and Europe. He then studied architecture and urban planning at Princeton University and received a Master of Architecture from Harvard University, where he later taught. He first came to Miami in 1975 to teach at the University of Miami. By 1977 he founded Arquitectonica with a group of young architects and set up a studio in Coconut Grove. Within two years, Arquitectonica's work was widely published around the world. Bernardo Fort-Brescia led the charge of expanding the firm across the country and abroad. The firm is known as one of the pioneers of globalization in the architecture profession. The firm's designs have defined modern Miami with projects that have carried the banner of Miami architecture around the world with skyscrapers, opera houses, resorts and new cities.

The HDA team work as architects, engineers, and design consultants, both independently and in collaboration with other architects and designers. Each project, from individual details to long-span structures, begins with a clear architectural idea with its own specific story to tell. The successful development of the idea is built on a thorough understanding of technical constraints.
